Dear UNITED

family,

THE LONG SHADOW OF THE FIRST GLOBAL PANDEMIC STILL LINGERS, WHILE THE MOST SEVERE THREAT ON HUMAN CIVILIZATION, WAR - A NUCLEAR WAR EVEN - HAS BEEN WITH US SINCE THE RUSSIAN MILITARY LAUNCHED ITS ATTACK AGAINST UKRAINE. IN ADDITION TO THE DEATH AND DESTRUCTION, THE WAR ALSO BROUGHT A RISE IN ENERGY PRICES LIKE NEVER BEFORE, PUTTING MILLIONS OF PEOPLE AT RISK DUE TO THE RISE OF UTILITY COSTS AND FOOD PRICES.

IT'S BEEN CRISIS AFTER CRISIS. POLITICAL CRISES IN HUNGARY, POLAND AND ITALY FUEL THE FEELING OF A SLOW AND INCOMPETENT EUROPEAN UNION, WHILE THE OLD CRISES SUCH AS MIGRATION, INEQUALITY, RACISM, AND CORRUPTION ARE ALMOST FORGOTTEN. UNITED HAS ASKED FOR MANY YEARS, QUO VADIS EUROPE? WHAT IS THE SOLUTION, WHAT IS YOUR VISION? IS THERE A DIRECTION OR IS IT JUST A CRAWL OF SMALL COMPROMISES, SOMETIMES LESS FORWARD THAN BACKWARDS?

UNITED FIRMLY BELIEVES IN THE CORE VALUES OF THE EU AND COE, OUR MAIN PARTNERS, AND WE ARE HAPPY TO LIVE UP TO YOUR STANDARDS IN CRITICIZING THEM, BUT ALSO TO OFFER SUPPORT AND SPACE FOR DISCUSSION AND DIALOGUE.

FOR 2022, WE ALSO HAD TO FOCUS ON REBUILDING AND REBRANDING THE NETWORK. WE CAN ONLY HOST SMALLER MEETINGS, TRAINING AND ONLINE CONFERENCES, AND WE KNOW THIS IS LESS THAN IDEAL AND THAT IT REPRESENTS A SHIFT FROM OUR USUAL STYLE, BUT NONETHELESS WE HAVE GONE ON AND ACQUIRED PROJECT FUNDING, AND WE WILL BE MORE ACTIVE WITH A LARGER SECRETARIAT.

WE HAVE A VISION AND WE WANT TO SHARE IT WITH YOU.

WE ARE ALSO IN THE PROGRESS OF BECOMING A BETTER SOURCE OF EUROPEAN HUMAN RIGHTS RELATED NEWS, INFORMATION AND POOL OF KNOWLEDGE. ALL WE NEED IS YOUR CONTINUOUS SUPPORT, YOUR ENGAGEMENT AND FEEDBACK. IN 2023 UNITED WILL ALSO BE 30 YEARS "YOUNG", OPENING UP FOR A YEAR OF CELEBRATIONS THAT WE WANT TO SHARE WITH YOU.

ACTION WEEK AGAINST RACISM

SUMMIT



THE SUMMIT WAS A TWO-HOUR SESSION WHERE IDEAS FROM THE NETWORK WERE COLLECTED IN ORDER TO DESIGN THE CAMPAIGN, TOGETHER WITH THE UNITED CAMPAIGNING TEAM.

THE SELECTED THEME HAS BEEN "SHOW YOUR HEART!"



EVERY YEAR, UNITED COORDINATES A WEEKLONG EUROPE-WIDE CAMPAIGN AROUND 21 MARCH TO PROTEST AGAINST ALL FORMS OF RACISM AND DISCRIMINATION, AND CELEBRATE THE DIVERSITY THAT ENRICHES EUROPEAN SOCIETIES.

THIS YEAR, THE CAMPAIGN RAN FOR TWO WEEKS, STARTING ON THE 14TH OF MARCH AND ENDING ON THE 27TH OF MARCH AND IT INVOLVED THE WIDER NETWORK ALSO IN THE PROCESS OF SHAPING THE CAMPAIGN! THAT'S WHY A 'CAMPAIGN SUMMIT' WAS HELD ON THE 25TH OF JANUARY, FROM 15:00 TO 17:00 CET ON ZOOM.

WITH THIS MOTTO PEOPLE HAVE BEEN INVITED TO WEAR THEIR HEART ON THEIR SLEEVE, DISPLAYING THEIR ANTI-RACISM ACTIVITY LIKE A BADGE OF HONOUR!

MICROVOLUNTEER, MICRO-CAMPAIGN, EVERY RANDOM ACT OF KINDNESS COULD BE DISPLAYED BY TAKING A PICTURE OF IT WITH THE HASHTAG **#SHOWYOURHEART.**

BUILD EUROPEAN SOLIDARITY TODAY

FOR MONTHS, THE STUDENTS HAVE WORKED WITH THEIR TEACHERS ON ANALYZING PHOTOS WHICH SPEAK OF DIVERSITY, DISCRIMINATION AND VALUES SUCH AS EQUALITY, SOLIDARITY, JUSTICE AND RESPECT, AFTER WHICH THEY RANDOMLY SELECTED THE RECIPIENT OF THE POSTCARD AND WROTE HIS MESSAGE OF SOLIDARITY.

THE POSTCARD CONSISTS OF TWO PARTS: ONE REMAINS WITH THE RECIPIENT, AND ON THE OTHER IT IS POSSIBLE TO SEND A REPLY TO THE STUDENT WHO WROTE THE MESSAGE OF SOLIDARITY. THIS SIMPLE, POETIC AND POLITICAL PROJECT DEMONSTRATES OUR COMMITMENT TO EDUCATION FOR EQUALITY IN DIVERSITY.

IN A PERIOD OF DOUBT AND SOMETIMES OF FRAGILITY, IT IS NECESSARY TO DO EVERYTHING POSSIBLE TO AVOID WITHDRAWAL BASED UPON DIFFERENT IDENTITIES AND TO CONTINUE TO BUILD A SOCIETY THAT IS PROUD OF ITS DIVERSITY. THROUGH THESE ACTIVITIES, EVERYONE CAN LEARN HOW TO DEBATE AND CONFRONT IDEAS AS WELL AS IMAGE READING AND WRITING. SOME OF THE PARTICIPATING SCHOOLS WILL GO ON ORGANIZING COMMUNITY ACTIONS TO ALSO PUT THIS THEORY IN PRACTICE.

THIS PROJECT IS BASED ON CIVIC EDUCATION AND ARTISTIC AND CULTURAL EDUCATION. IT IS INSPIRED BY A PROJECT THAT THE FRENCH ORGANIZATION LA LIGUE DE L'ENSEIGNEMENT HAS BEEN IMPLEMENTING IN FRANCE FOR TWO DECADES.

THE TOPIC OF RACISM IS IN THIS SCHOOL YEAR THEMATIZED THROUGH A PHOTO BY EDU LEÓN CALLED 'INVISIBLE BORDERS' DESCRIBING POLICE ROUND-UPS IN SPAIN BASED ON RACIAL PROFILING.

SINCE 1993, THE UNITED LIST OF REFUGEE DEATHS HAS RECORDED THE REPORTED CASES OF DEATHS OF MORE THAN 48,647 REFUGEES AND MIGRANTS WHO HAVE DIED DUE TO THE RESTRICTIVE POLICIES OF FORTRESS EUROPE WHILST TRYING TO GET INTO EUROPE.

AMONG OTHERS IN 2022, THE LIST OF REFUGEE DEATHS WAS USED IN THE FOLLOWING WAYS:

THE FLOOD BY TINA FARIFTEH AIMS TO DISSECT THE WATER METAPHOR—TO UNDERSTAND AND VISUALISE THE DOMINANT DISCOURSE ON MIGRATION AND QUESTION THE FRAMING OF REFUGEES AS A NATURAL DISASTER. REFUGEE LIVES MATTER

- ON THE 2ND OF JULY, IN BIELEFELD, GERMANY, THE SEEBRÜCKE BIELEFELD ORGANISED A CULTURAL EVENT "MUSIC & MOVEMENT FOR EVERYONE". AROUND 20 DIFFERENT STENCILS WITH THE NAMES OF PEOPLE WHO DIED BECAUSE OF "FORTRESS EUROPE'S" DEADLY BORDER REGIME. THE IDEA WAS TO HAVE ONE STENCIL WITH A NAME, BIRTH DATE AND THE DATE OF DEATH - AND A SECOND STENCIL WITH WORDS LIKE "BORDERS KILL" OR "ABOLISH FORTRESS EUROPE", SO PEOPLE CAN TAKE THE STENCILS AND SPRAY-CHALK THEM IN THE PUBLIC SPACE OF THE CITY.

how did we do it



WE THOUGHT THAT OUR CAMPAIGN COULD SUPPORT THE INVESTIGATION OF THE WAYS IN WHICH NEO-FASCIST PARTIES AND LEADERS WHO ARE NOW MAINSTREAM, TALK AND COMMUNICATE ON SOCIAL MEDIA; THEIR VOCABULARY, IMAGES, TARGETS, HOW CAN WE SPOT THEM? WHICH SIMILARITIES DO THEY BRING WITH THE FASCISM OF "THE PAST"?

WE CANNOT AFFORD TO LEAVE TERRAIN TO FASCISM BUT WE ARE ALREADY DOING IT BY NEGLECTING AND UNDERVALUING THE RISKS AND THE STRENGTH OF ITS LANGUAGE ON SOCIAL MEDIA AND WITHIN COMMUNICATION IN GENERAL. THAT'S WHY WE MOBILISED ON THE 9TH OF NOVEMBER, TO STRESS THE IMPORTANCE OF REMEMBRANCE AS SOMETHING ACTIVE, NOT PASSIVE, AN ACT OF RESISTANCE THAT MUST BE COLLECTIVE AND UNIFYING, THAT SHOULDN'T BECOME NOSTALGIA, NOR ERASE THE HISTORY OF VICTIMS, NONE OF THEM (INCLUDING ROMA, LGBTQI+ PEOPLE AND PEOPLE WITH DISABILITIES).

TO ACHIEVE THIS PURPOSE WE MOVED ON TWO DIFFERENT LEVELS, CREATING A CATCHY SOCIAL MEDIA CAMPAIGN AND LAUNCHING OUR VERY FIRST INSTAGRAM LIVESTREAM, PRODUCING MORE THAN 60 DIFFERENT CONTENTS SHARED THROUGHOUT FACEBOOK, TWITTER AND INSTAGRAM.

INSTAGRAM IN PARTICULAR REPRESENTED AN INNOVATION FOR OUR NETWORK'S CAMPAIGNING, SYMBOLISING THE WILL TO INNOVATE OUR PRACTICE AND COMMUNICATION STYLES TO ADAPT TO CURRENT SCENARIOS AND SWIFTING DYNAMICS SURROUNDING SOCIAL MEDIA.

FOR THIS YEAR'S CAMPAIGN AGAINST FASCISM AND ANTISEMITISM WE DECIDED TO FOCUS ON ACTIVISM, COMMUNICATION AND LANGUAGE.

CONSIDERING THE 2022 SCENARIO IN FACT, WITH AN ONGOING PANDEMIC, UNDERLYING EVERYONE'S LIVES WHILE BEING MORE AND MORE NORMALISED IN ITS EFFECTS, WITH CONFLICTS AND GLOBAL CRISIS CLUTTERING EVERY COMMUNICATION SPACE, WE FELT THE NEED TO WORK ON A CAMPAIGN THAT WOULD INVITE PEOPLE, ESPECIALLY YOUNGER ONES, TO FEEL EMPOWERED IN EXPLORING THE VARIOUS POSSIBILITIES OF ACTIVISM, REFLECTING ON THE ROLE OF MEMORY FOR CREATING AWARENESS AND CONTRASTING THE SPREAD OF FASCIST AND DISCRIMINATORY IDEALS.

THAT'S WHY WE SAID: NOT TODAY FASCISM, NOT TODAY!

AS WE KNOW AND ALWAYS REMIND OUR AUDIENCE, 9TH OF NOVEMBER IS AN HISTORICAL COMMEMORATION OF THE TRAGIC EVENTS OF THE KRISTALLNACHT OF 1938, TO REMEMBER THE DANGERS OF FASCISM AND HOW IT LED TO THE EXTERMINATION OF MILLIONS OF PEOPLE ALL OVER EUROPE.

WE HAVE BEEN COMMEMORATING THESE EVENTS FOR 30 YEARS NOW AND ALL OVER EUROPE IT HAS BECOME A DAY FOR REMEMBRANCE, FOR THE VICTIMS, THEIR FAMILIES AND TO PREVENT SUCH HORRORS FROM EVER HAPPENING AGAIN.

NONETHELESS THE FAR RIGHT AND FASCISM HAVE BEEN CONSTANTLY GROWING IN POPULARITY NOT LIMITED TO SMALL EXTREMIST GROUPS, HIDDEN IN THEIR FORUMS, CLUBS, PARTIES, BUT REPRESENTING RELEVANT PERCENTAGES WITHIN PARLIAMENTS, IN FRANCE, ITALY, HUNGARY, SPAIN, POLAND AND MANY OTHER COUNTRIES. THIS HAPPENED DURING THE DECADE THAT SAW A MASSIVE CHANGE IN THE MEANS OF COMMUNICATION, WITH THE DOMINATION OF SOCIAL MEDIA OVER PUBLIC LIFE, INFORMATION AND PROPAGANDA.

FOR THIS REASON ANY ACTION AND ANY ACTIVIST WHICH AIMS TO INTERVENE AND TO CONTRAST THIS WORRYING TREND MUSTN'T IGNORE THE MORE SUBTLE WAYS IN WHICH SUCH IDEOLOGIES KEEP SPREADING AND INTOXICATING OUR COMMON SPACES.

IT'S SURELY NOT A COINCIDENCE THEN THAT MUCH OF THE CURRENT ACTIVIST BATTLES ARE CONDUCTED WITHIN ONLINE SPACES AND ON DIGITAL PLATFORMS, BECAUSE IT'S WHERE WE NEED TO BE. THIS DOESN'T AND SHOULDN'T MEAN THAT WE SHOULD BECOME DETACHED FROM THE STREETS OR THAT WE SHOULD NEGLECT MORE PHYSICAL CONNECTIONS, BUT THAT WE MUST LEARN TO MOVE ALSO IN THESE FIELDS.

IN THIS PERSPECTIVE WE BELIEVED THAT UNITED COULD REPRESENT THE PERFECT ACTOR TO FOSTER AND TO IMPROVE A MORE ACTIVIST APPROACH IN REMEMBRANCE, TAKING ADVANTAGE OF ITS LONG HISTORY AND STRONG NETWORK AND TO COMBINE THE TRADITION AND EXPERIENCE OF THE GREATEST ANTI FASCIST MOVEMENTS, WITH THE MORE RECENT VENTURES WITH THE NO HATE SPEECH MOVEMENT CAMPAIGN AND WITH ONLINE ACTIVISM.

ONLY BY GIVING THIS ACTIVIST ROLE TO MEMORY IN FACT, WE CAN CREATE EFFECTIVE STRATEGIES AGAINST FASCISM, WHICH IS SOMETHING THAT DEVELOPED THROUGH THE YEARS AND THAT NEEDS A SYSTEMIC APPROACH TO BE CONTRASTED.

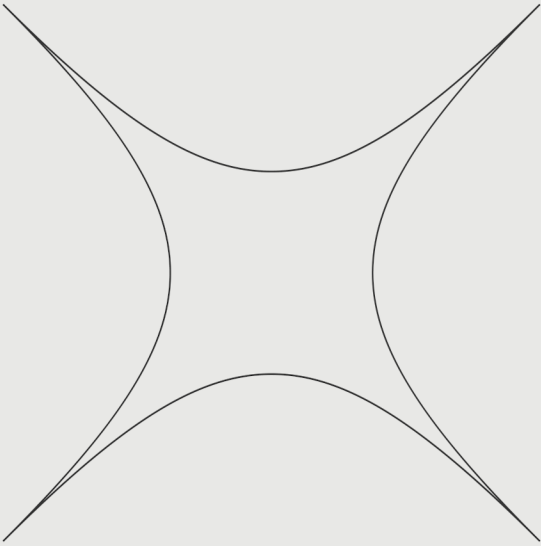

ACTIVIST LIVESTREAM

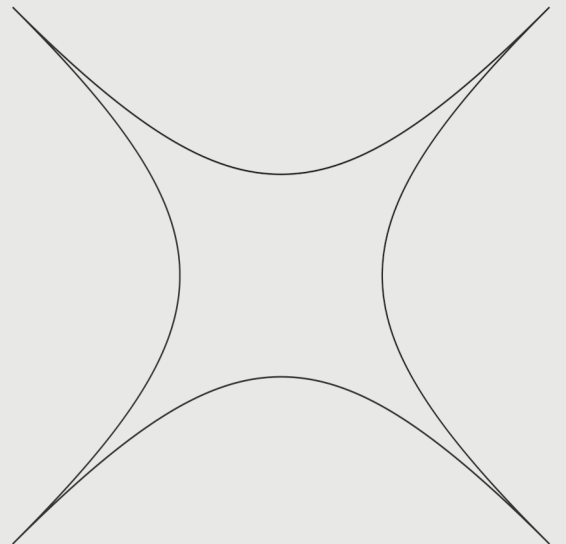
TO CATCH EVEN MORE ATTENTION, ESPECIALLY THAT OF YOUNG PEOPLE, WE DECIDED TO COMBINE OUR CAMPAIGNING WITH THE LAUNCH OF OUR VERY FIRST INSTAGRAM LIVESTREAM, WITH THE IDEA OF INAUGURATING A NEW FORMAT, THE ACTIVIST LIVESTREAM, FOLLOWING ON OUR TRADITION OF DIALOGUES, PANELS, DEBATES, CONFERENCES AND THE INTENSIFICATION OF OUR ONLINE PRESENCE WITH SUCH INITIATIVES.

FOR THE 9TH OF NOVEMBER WE HAD THE PRIVILEGE TO HOST KHADIJA TIRHA, AN INTERSECTIONAL AND EXPERT ACTIVIST WHO SHARED WITH US HER EXPERIENCE AS AN AFRO-EUROPEAN YOUTH WORKER BASED IN ITALY, PROVIDING TIPS AND ADVICE FOR YOUNG PEOPLE ON HOW TO SPOT "RED FLAGS, WORRYING ATTITUDES AND EXPRESSIONS CONNECTED WITH FASCISM, RACISM AND DISCRIMINATION.

IN ADDITION TO THAT KHADIJA ALSO PROVIDED US WITH INCREDIBLE GOOD VIBES, EMPOWERING EVERYONE TO KEEP RESISTING AND TO ALWAYS FIND THE MOTIVATION TO KEEP UP WITH OUR BATTLES, TAKING CARE OF OURSELVES AND OF THE PEOPLE SURROUNDING US, BEING ABLE TO DECIDE WHEN WE NEED TO LET IT GO.

REFUGIN "COMMUNITARIAN APPROACH FOR A HOLISTIC REFUGEE LONG-TERM INTEGRATION" ADDRESSES THREE OUT OF THE FOUR PRIORITIES PRESENTED IN THE PARTNERSHIPS FOR COOPERATION, SPECIFICALLY BY PROMOTING "INCLUSION AND DIVERSITY IN ALL FIELDS OF EDUCATION, TRAINING, YOUTH AND SPORT", "ADDRESSING DIGITAL TRANSFORMATION THROUGH THE DEVELOPMENT OF DIGITAL READINESS, RESILIENCE AND CAPACITY", AS WELL AS FOMENTING "COMMON VALUES, CIVIC ENGAGEMENT AND PARTICIPATION". ADDITIONALLY, REFUGIN WILL RESPOND TO THREE SPECIFIC PRIORITIES IN THE FIELD OF YOUTH, NAMELY THROUGH "PROMOTING ACTIVE CITIZENSHIP, YOUNG PEOPLE'S SENSE OF INITIATIVE AND YOUTH ENTREPRENEURSHIP", "STRENGTHENING THE EMPLOYABILITY OF YOUNG PEOPLE" AND "REINFORCING THE LINKS BETWEEN POLICY, RESEARCH AND PRACTICE".

CONSIDERING THESE PRIORITIES, REFUGIN WILL COMPREHENSIVELY ENHANCE EDUCATIONAL AND NGOS' PROFESSIONALS' KNOWLEDGE AND SKILLS REGARDING COMPREHENSIVE WORK WITH YOUNG REFUGEES, THUS PROMOTING THEIR ACTIVE ENGAGEMENT AND IMPACT IN PROMOTING SOCIAL INCLUSION AND TOLERANCE AND CONTRIBUTING TO A HOLISTIC MEDIUM LONG TERM INTEGRATION OF YOUNG REFUGEES. FOLLOWING THIS BROADER OBJECTIVE, REFUGIN COMPRISES SPECIFIC OBJECTIVES, NAMELY:

- TO COMPREHEND THE NEEDS OF YOUNG REFUGEES IN EUROPEAN COUNTRIES AND THOSE OF THE PROFESSIONALS WORKING WITH THEM TO FACILITATE THEIR MEDIUM- LONG TERM INTEGRATION AND, THEREFORE, WELL-BEING;
- TO CAPACITATE RELEVANT ACTORS, NAMELY SCHOOLS' COMMUNITIES AND COMMUNITY ORGANISATIONS, TO BETTER UNDERSTAND FORCED MIGRATION, AS WELL AS THE RISKS OF SOCIAL EXCLUSION AND ITS CONSEQUENCES, AIMING TO BREAK THE STIGMA OF MIGRATION-CRIME/TERRORISM;
- TO PROMOTE COMMUNITARIAN DYNAMICS TO ENABLE SOCIAL AWARENESS, RECEPTIVITY AND INTERCULTURAL DIALOGUE, AS WELL AS PROMOTING INFORMED, INCLUSIVE AND TOLERANT EDUCATIONAL AND COMMUNITARIAN ENVIRONMENTS FOR REFUGEES TO STRIVE;
- TO PROVIDE A COMPREHENSIVE FRAMEWORK ON THE REALITY EXPERIENCED BY YOUNG REFUGEES, AT THE MICRO, MESO AND MACRO LEVEL, DESIGNED FOR EDUCATIONAL AND NGOS' PROFESSIONALS;
- TO CAPACITATE RELEVANT ACTORS ON UNIFORMISED STRATEGIES TO ADDRESS THE SPECIFIC CHALLENGES YOUNG REFUGEES FACE;
- TO FOSTER SYNERGIES AMONGST RELEVANT FRONT-LINE PRACTITIONERS (FLP) DEALING WITH REFUGEES, TO PROMOTE THE EXCHANGE OF EXPERIENCES AND PROMISING PRACTICES, INCLUDING EDUCATIONAL ACTORS;
- TO INCREASE YOUNG REFUGEES' PERSONAL, EDUCATIONAL AND SOCIAL SKILLS.

AIMS TO:

IN OCTOBER, WE STARTED THE MONITORA PROJECT, WHICH AIMS TO STRENGTHEN THE PROFESSIONAL SKILLS AND COMPETENCIES OF CSO'S AND GRASSROOTS SPORT OPERATORS, LOCAL AND NATIONAL INSTITUTIONS IN MONITORING AND REPORTING DISCRIMINATION AND RACISM IN GRASSROOTS SPORT, TO FACILITATE THEIR VISIBILITY AND TO IDENTIFY STRATEGIC ACTIONS AIMED AT PREVENTING AND COUNTERING THEM.

THE LAST DECADE WITNESSED CONSIDERABLE CHANGES IN EUROPEANS' PERCEPTIONS AND AWARENESS OF RACISM IN SPORT AND THE NEED FOR ACTION. INDEED, OPEN FORMS OF RACISM AND ETHNIC DISCRIMINATION IN SPORT HAVE BECOME A EUROPEAN ISSUE. HOWEVER, WITH SOME NOTABLE EXCEPTIONS, THERE STILL SEEMS TO BE A GREATER FOCUS ON OPEN RACISM, MAINLY ATTRIBUTED TO SPECTATORS, WITH LESS EMPHASIS ON MORE HIDDEN FORMS OF STRUCTURAL RACISM.

STRENGTHEN THE PROFESSIONAL SKILLS AND COMPETENCIES OF CSO'S, GRASSROOTS SPORTIVE ASSOCIATIONS, NATIONAL AND LOCAL INSTITUTIONS TO MONITOR, DOCUMENT AND REPORT DISCRIMINATION AND RACISM IN GRASSROOTS SPORT IN 4 EU COUNTRIES

COLLECT, ANALYSE AND SHARE THE METHODOLOGIES ADOPTED AT LOCAL AND NATIONAL LEVEL TO STRUCTURING A MONITORING SYSTEM OF DISCRIMINATION AND RACISM IN SPORT;

STRENGTHEN NETWORKING AT LOCAL, NATIONAL AND INTERNATIONAL LEVEL TO DESIGN A MONITORING PROTOCOL PROPOSAL.

DEVELOP, TESTI AND DISSEMINATE A TRAINING MODULE TO ENHANCE THE PROFESSIONAL MONITORING AND REPORTING SKILLS OF CSO'S OPERATORS, SPORTIVE OPERATORS AND INSTITUTIONAL REPRESENTATIVES.

RADICALISATION AND VIOLENT EXTREMISM PREVENTION IN THE COMMUNITY

THE R2COM "RADICALISATION AND VIOLENT EXTREMISM PREVENTION IN THE COMMUNITY" PROJECT INTENDS TO ENHANCE NGOS' INVOLVEMENT, KNOWLEDGE, SKILLS AND NETWORKING IN THE P/CVE FIELD. THE PROJECT WILL PRODUCE RELIABLE TRAINING MATERIAL TO PROPERLY SUPPORT, GUIDE AND CAPACITATE NGOS' ACTION WHEN WORKING WITH RADICALISED/VULNERABLE INDIVIDUALS. THE PROJECT INTENDS TO ENHANCE NGOS' INVOLVEMENT, KNOWLEDGE, SKILLS AND NETWORKING IN THE P/CVE FIELD. THE PROJECT WILL PRODUCE RELIABLE TRAINING MATERIAL TO PROPERLY SUPPORT, GUIDE AND CAPACITATE NGOS' ACTION WHEN WORKING WITH RADICALISED/VULNERABLE INDIVIDUALS.

SPECIFIC OBJECTIVES:

TO EXPAND KNOWLEDGE AND COMPREHENSION REGARDING "WHAT WORKS" AND "WHAT DOES NOT WORK" IN THE INVOLVEMENT OF NGOS IN P/CVE;

TO WIDEN OPPORTUNITIES FOR KNOWLEDGE, EXPERIENCES, AND EXPERTISE SHARING BETWEEN NGOS WORKING IN P/CVE;

TO DEEPEN THE INVOLVEMENT OF NGOS IN P/CVE INITIATIVES AND FOLLOW-UP/AFTERCARE PROVISIONS;

TO PROMOTE ADEQUATE PRACTICES TO PROPERLY RESPOND TO THE NEEDS OF NGOS' PROFESSIONALS IN P/CVE;

TO PRODUCE RELIABLE MATERIAL TO APPROPRIATELY SUPPORT AND GUIDE NGOS' ACTIONS WHEN WORKING WITH VULNERABLE INDIVIDUALS;

TO ESTABLISH A STEADY RADICALISATION RISK SCREENING TOOL, APT TO BE USED BY NGOS TO ASSESS INDIVIDUALS' "PROPENSITY TOWARDS ENGAGEMENT" INTO RADICAL VIEWPOINTS/ACTIVITIES.

OVER THE LAST FEW YEARS WE HAVE WITNESSED CONTINUOUS DIGITIZATION PROCESSES IN VARIOUS CONTEXTS (EDUCATION, WORK, SOCIALITY, COMMUNICATION, CONSUMPTION, PARTICIPATION AND CITIZENSHIP, ETC.) WHICH HAVE CONTRIBUTED TO THE IMPROVEMENT OF SOME PRACTICES MAKING THEM MORE DYNAMIC AND INNOVATIVE, BUT DEVELOPING IN PARALLEL ALSO NEW SOCIAL CHALLENGES LINKED TO THE NOT ACCURATE USE OF NEW DIGITAL TECHNOLOGIES AND THE CYBER SPACE.

CHILDREN, TEENAGERS AND ADULTS ARE EQUALLY EXPOSED, ALBEIT WITH DIFFERENT RESULTS, TO THE SAME RISKS; IT IS ALSO EVIDENT THAT MORE AND MORE PEOPLE ARE VICTIMS OF ADDICTION, ABUSE OR DISTORTED USE OF DIGITAL TOOLS AND RESOURCES.

SAFETY AWARENESS IN DIGITAL ERA

IN THIS CONTEXT, THE PROJECT "SAFETY AWARENESS IN DIGITAL ERA" AIMS TO CONTRIBUTE TO INCREASING THE DIGITAL SKILLS OF YOUNG PEOPLE AND YOUTH WORKERS IN A SPECIFIC THEMATIC AREA (SECURITY, WELL-BEING AND DIGITAL PRIVACY) WHICH, ALTHOUGH OF CONSIDERABLE IMPORTANCE FOR A CONSCIOUS AND APPROPRIATE USE OF DIGITAL TOOLS, IT IS OFTEN ADDRESSED IN AN INCOMPLETE WAY OR WITH AN INACCESSIBLE LANGUAGE.

SINCE THE DIRECT INVOLVEMENT OF YOUNG PEOPLE IS FUNDAMENTAL TO RAISE AWARENESS ON THESE ISSUES, THROUGH THE PROJECT WE AIM TO TRIGGER DYNAMICS THAT SEE YOUNG PEOPLE AS MESSENGERS AND PROMOTERS TOWARDS THEIR PEERS IN A LOGIC OF PEER EDUCATION AND ENHANCEMENT OF CIVIC PARTICIPATION FOR COLLECTIVE WELL-BEING.

SPECIFIC OBJECTIVES:

INCREASE PARTICIPANTS' DIGITAL SKILLS IN RELATION TO SECURITY, WELL-BEING, PRIVACY, ENHANCE CRITICAL THINKING TOWARDS THE CYBER ENVIRONMENT AND ITS POTENTIAL RISKS, BUILD SKILLS FOR ONLINE SELF-DEFENSE OF ONESELF AND OTHERS;

INCREASE THE SENSE OF INITIATIVE AND CREATIVITY OF YOUNG PEOPLE BY INVOLVING THEM IN THE CREATION OF ESCAPE ROOMS AIMED AT THEIR PEERS ON THE ISSUES OF SECURITY, DIGITAL WELL-BEING, AND PRIVACY;

ACTIVELY CONTRIBUTE TO THE CONSTRUCTION OF SOCIAL WELL-BEING AND SECURE DIGITAL COMMUNITIES;

EMPHASIZE THE APPROPRIATE USE OF ONLINE AND OFFLINE MULTIMEDIA TECHNOLOGIES AMONG PARTICIPANTS;

DEVELOP NEW DIGITAL SKILLS IN YOUTH WORKERS TO BECOME A MODEL FOR THEIR TARGET AUDIENCE AND BUILD TOGETHER MORE ENGAGING AND PARTICIPATORY INITIATIVES ON THE ISSUES OF DIGITAL SECURITY, PRIVACY, AND WELL-BEING;

INCREASE THE KNOWLEDGE OF YOUTH WORKERS ON ONLINE / OFFLINE DIGITAL SAFETY AND WELLBEING PRACTICES.

TAYA

TRAINING ACTIVE YOUTH WORKERS IN ANTI-DISCRIMINATION EDUCATION

THE OVERALL OBJECTIVE OF TAYA IS TO FURTHER QUALIFY EUROPEAN YOUTH WORKERS AS TRAINERS FOR ANTI-DISCRIMINATION-EDUCATION. BY THIS THE IDEA IS TO ENABLE THEM TO RAISE AWARENESS ABOUT DISCRIMINATION IN GENERAL AND WITH AN EMPHASIS ON RACISM, XENOPHOBIA AND THE DISCRIMINATION AGAINST REFUGEES AND MIGRANTS IN PARTICULAR IN THEIR DAILY WORK.

THE PROJECT AIMS AT SENSITIZING AND RAISING AWARENESS AMONG YOUTH WORKERS THROUGH SELF-REFLECTION AND KNOWLEDGE EXCHANGE AS WELL AS TRAINING THEM AS MULTIPLIERS TO IMPLEMENT ACTIVITIES ADDRESSING (RACIAL) DISCRIMINATION AND PREJUDICES REGARDING REFUGEES, MIGRANTS AND OTHER VULNERABLE GROUPS IN THEIR COMMUNITIES AS WELL AS THE VARIOUS INTERSECTIONS WITH OTHER FORMS OF DISCRIMINATION. LIKEWISE, THE INITIATIVE WILL BOLSTER A HOLISTIC UNDERSTANDING OF THE SPATIAL ISSUE OF STRUCTURAL RACISM AND RELATED SOCIAL ISSUES AND WILL TEACH THE TARGET GROUP TO MAINSTREAM ANTI-DISCRIMINATORY PRACTICES AND ATTITUDES IN THEIR WIDER WORK WITH YOUTH. IN THIS WAY, THE INITIATIVE CONTRIBUTES TO THE ACCEPTANCE OF AND TOLERANCE TOWARDS REFUGEES, MIGRANTS, BLACK PEOPLE AND POCS IN EUROPE. THUS IT GOES IN LINE WITH THE EUROPEAN COUNCIL DIRECTIVE 2000/43/EC IMPLEMENTING THE PRINCIPLE OF EQUAL TREATMENT BETWEEN PERSONS IRRESPECTIVE OF RACIAL OR ETHNIC ORIGIN.

A NEEDS ASSESSMENT REVEALED THAT ANTI-RACIST TRAINING RESOURCES ARE STILL UNDERREPRESENTED IN THE SPECTRUM OF ERASMUS + INITIATIVES AND THEIR OUTPUTS: WHILE THE COMPETENDO-PLATFORM PROVIDES RESOURCES ON A VARIETY OF TOPICS, ANTI-RACIST TRAINING KNOWLEDGE SHOULD BE EXPANDED. COMPETENDO CONFIRMED TO US THE NEED OF A GUIDELINE FOR RACISM-SENSITIVE PROJECT DEVELOPMENT, WHICH IS TO BE INCORPORATED ON THE HOMEPAGE AS WELL AS ARTICLES AND A MANUAL ON THE ISSUE. THIS INITIATIVE WILL USE ITS NON-FORMAL, INTERACTIVE TRAININGS TO DEVELOP THESE RESOURCES IN THE FORM OF ANTI-DISCRIMINATORY FACILITATION GUIDELINES FOR EUROPEAN YOUTH WORKERS.

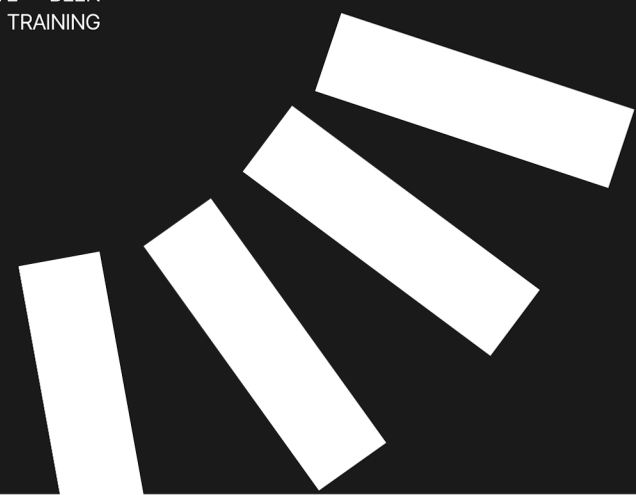
SPECIFIC OBJECTIVES:

ENABLE YOUTH FACILITATORS TO INTEGRATE ANTI-RACISM ACTION INTO THEIR WORK: IMPLEMENT ANTI-DISCRIMINATORY ACTIVITIES, WHICH AIM AT EDUCATING YOUTH IN THEIR COMMUNITIES ON THE TOPIC AREA OF DISCRIMINATION WITH AN EMPHASIS ON RACISM, FLIGHT AND MIGRATION AS WELL AS MAINSTREAMING ANTI-DISCRIMINATION AND CRITICAL-WHITENESS APPROACHES AS A SPATIAL ISSUE INTO THEIR DAY-TO-DAY FACILITATION WORK.

A HIGHER AWARENESS AMONG THE REACHED MEMBERS OF THE TARGET GROUPS CONCERNING (RACIAL) DISCRIMINATION, LIFE REALMS OF REFUGEES AND STRUCTURAL PREJUDICES AGAINST REFUGEES, BLACK PEOPLE AND POC TO BE MEASURED BY A QUALITATIVE AND QUANTITATIVE POLL AFTER THEY HAVE BEEN ATTENDING THIS PROJECT TRAINING COMPONENTS.

AN INCREASING AWARENESS AND SENSITIVITY AMONG THE FINAL BENEFICIARIES ABOUT ISSUES OF (RACIAL) DISCRIMINATION, MIGRATION, XENOPHOBIA AND IN ORDER TO WORK TOWARDS MORE SOCIAL EQUALITY IN THEIR COMMUNITIES TO BE MEASURED BY A QUALITATIVE AND QUANTITATIVE POLL AFTER THEY HAVE BEEN ATTENDING AT LEAST ONE RELEVANT EVENT FACILITATED BY THE YOUTH WORKERS TRAINED BY THIS PROJECT.

SPREAD THE FINDINGS OF THIS PROJECT THROUGH A FACILITATION GUIDELINE, DISTRIBUTED ACCORDING THE PROJECT-SPECIFIC DISSEMINATION.



CHAPTER

CHALLENGING PROPAGANDA THROUGH REMEMBRANCE

SINCE 2014 EUROPE IS IN FACT FACING THE WORST HUMANITARIAN CRISIS OF REFUGEES SINCE WORLD WAR II (WWII), THE MAJORITY OF THEM FLEEING FROM SYRIA AND LIBYA, WHILE THE ECONOMIC CRISIS HAS BEEN CAUSING CUTS TO SOCIAL INCLUSION, EDUCATION AND HEALTHCARE PROGRAMMES.

POPULIST GROUPS' MEDIA DEPICTS THIRD-COUNTRY NATIONALS AS EXPLOITERS OF THE WELFARE SYSTEM WHILE CRIMINALIZING CIVIL SOCIETY ORGANIZATIONS IN SOLIDARITY, THUS FUELLING SOCIAL TENSIONS INTO ORGANIZED VIOLENCE AGAINST PEOPLE AND INSTITUTIONS. AN IN-DEPTH ANALYSIS SHOWS THAT CURRENT PROPAGANDA ROOTS IN METHODOLOGIES AND TOOLS DEVELOPED UNDER TOTALITARIAN REGIMES. NAZISM AND FASCISM EMPHASIZED THOSE FEATURES CHARACTERIZING THE PUBLIC DISCOURSE DURING WORLD WAR I AND ITS AFTERMATH SUCH AS NATIONALISM, HATRED OF THE ENEMY AND DEHUMANIZATION: ALL OF THAT CONTRIBUTED TO LAY THE GROUNDWORK FOR WWII.

THE CHAPTER – CHALLENGING PROPAGANDA THROUGH REMEMBRANCE PROJECT IS AIMING AT CASTING A LIGHT ON PROPAGANDA BEFORE AND DURING WWII, FOCUSING ON ITS ROLE TO ENFORCE THE CONCEPT OF “ENEMY” – FROM NATIONAL AND ETHNIC GROUPS TO POLITICAL OPPONENTS AND SOCIAL GROUPS.

THE FINAL EVENT OF CHAPTER PROJECT WAS HELD IN ROME ON THE WEEKEND OF 6TH AND 7TH NOVEMBER: HISTORICAL, INTELLECTUAL AND MILITANT SUBJECTS, FROM DIFFERENT EXPERIENCES AND DIFFERENT AREAS OF THE WORLD MET IN THREE EVENTS OPEN TO THE PUBLIC, IN DIFFERENT SPACES OF THE CITY. ALL ORGANISATIONS HAVE BROUGHT THEIR
EXPERIENCE AND RANGE IN THEIR HOME
COUNTRIES WHICH HELPED THE CIVILIAN
SOCIETY OBTAIN A MORE COMPREHENSIBLE
BASIS IN ORDER TO ENGAGE MORE IN THE
PUBLIC DISCUSSION AND PROCESS
THEMSELVES.

THIS CLOSE COOPERATION MADE IT
POSSIBLE TO GAIN AN INSIGHT INTO THE
COMPLEXITY OF THE DECISION-MAKING
PROCESS AND THE CONTRADICTIONS AND
SUPPORTED THE GOAL OF PROMOTING
NATIONAL AND TRANSNATIONAL CIVIL
SOCIETY STRUCTURES AND ACTIVITIES.

THE INDIVIDUAL NGOS WERE CLOSELY
FOLLOWING THE SPECIFIC DISCUSSION
PROCESS IN THEIR RESPECTIVE COUNTRIES
AS WELL AS AT THE EUROPEAN LEVEL AND
CONSTANTLY EXCHANGING INFORMATION
AND INSIGHTS WITH THE OTHER PARTNERS.
EVENTUALLY THE RESULTS WERE
PRESENTED IN PUBLIC STATEMENTS, ON
VARIOUS SOCIAL MEDIA CHANNELS AND
DURING EVENTS.

IN MARCH 2022 UNITED HOSTS THE HUMAN
RIGHTS FAIR, AN EVENT CREATED IN ORDER
FOR THE CIVIL SECTOR TO BE ABLE TO MEET
THE DECISION MAKERS. FOR THIS PURPOSE
WE INVITED POLITICIANS AND
REPRESENTATIVES OF INSTITUTIONS TO
DISCUSS THE FUTURE OF HUNGARY AND
HUMAN RIGHTS WITH A SPECIAL FOCUS ON
THE EU-ASYLUM-PACT AND SPREAD
INFORMATION ABOUT THE SPECIFIC ROLE OF
HUNGARY IN THE EU-MIGRATION AGENDA, AS
WELL AS THE RELEVANCE OF THE CIVIL
SOCIETY ACTIVITIES IN TIMES OF POPULISM
AND NATIONAL EGOISM. UNITED ALSO
HELPED TO ORGANISE OTHER WEBINARS AND
CONFERENCES IN THE PARTNER COUNTRIES.

INFORMAL PARTICIPATORY EDUCATION ON ANTISEMITISM & HOLOCAUST

FOR THE LAST FEW YEARS, THERE HAS BEEN AN UNDENIABLE RISE OF ANTISEMITISM ALL ACROSS THE EUROPEAN CONTINENT, INCLUDING INCREASED ANTI-SEMITIC VIOLENCE AND THE EMERGENCE OF NEO-NAZI POLITICAL PARTIES. A 2018 SURVEY BY THE EU'S FUNDAMENTAL RIGHTS AGENCY (FRA) ON EXPERIENCES AND PERCEPTIONS OF ANTISEMITISM IN EUROPE FOUND OUT THAT 89% OF JEWS LIVING IN 13 EUROPEAN COUNTRIES FEEL ANTISEMITISM HAS INCREASED IN THEIR COUNTRY OVER THE PAST DECADE, WHILE 85% BELIEVED IT TO BE A SERIOUS PROBLEM. THIS ELEVATED HATRED AGAINST THE JEWISH PEOPLE ONLY GOT WORSE DURING THE PANDEMIC, AS PROTESTERS AGAINST THE COVID-19 MEASURES ARE PRONE TO HAVE AN ANTI-SEMITIC NARRATIVE.

CONSIDERING THAT THESE FAR-RIGHT, RACIST MOVEMENTS ARE LIKELY TO INFLUENCE THE FRAGILE MINDS OF THE YOUTH, A PROPER EDUCATION ON ANTISEMITISM AND HOLOCAUST IS MORE THAN IMPORTANT TO SUBVERT THE STATUS QUO. FORMAL EDUCATION IS ALREADY BEING PUT IN PLACE TO EDUCATE YOUNG PEOPLE ABOUT THE GRAVITY OF THE SITUATION, BUT IT HAS ITS INEVITABLE LIMITATIONS. MEETING WITH HOLOCAUST SURVIVORS AND OTHER TRADITIONAL FORMS OF FACE-TO-FACE EDUCATION IS POWERFUL BUT WILL NO LONGER BE POSSIBLE OR WILL REQUIRE TOO MUCH RESOURCES, HENCE MAKING THEM A DIFFICULT ROAD TO TAKE; THIS IS EXACTLY WHERE IPEAH COMES INTO PLACE AS AN ALTERNATIVE APPROACH TO EDUCATE THE EUROPEAN YOUTH IN A MORE INNOVATIVE AND CREATIVE WAY. NOW IS THE TIME WHERE PROJECTS LIKE IPEAH ARE NEEDED MORE THAN EVER.

IN FEBRUARY OF 2021 UNITED FOR INTERCULTURAL ACTION ANNOUNCED THE LAUNCHING OF A NEW PROJECT THAT WE TOOK PART IN, IN COLLABORATION WITH INSTITUT LUDSKYCH PRAV – HUMAN RIGHTS INSTITUTE (CZECH REPUBLIC) AND SOS RAZZISMO ITALIA (ITALY) – IPEAH (INFORMAL PARTICIPATORY EDUCATION ON ANTISEMITISM AND HOLOCAUST). A PILOT PROJECT CREATED TO TEST NEW METHODS TO REMEMBER HOLOCAUST AND FIGHT AGAINST ANTISEMITISM AND RACIST HATRED, IPEAH WILL AIM AT BECOMING A BLUEPRINT OF A NEW INNOVATIVE EDUCATIONAL PROGRAM ON ANTISEMITISM AND HOLOCAUST THAT MANY EUROPEAN COUNTRIES COULD ADOPT.

AS A PILOT PROJECT, IPEAH IS FIRSTLY PLANNING TO FOCUS ON THE YOUNG PEOPLE OF SLOVAKIA AS ITS TARGET AUDIENCE, WITH AN AGE GROUP RANGING FROM 14 TO 19 YEARS OLD. AS A COUNTRY WITH A COMPLEX HISTORY OF THE HOLOCAUST AND GROWING SUPPORT FOR THE NEO-NAZI PARTY IN PARLIAMENT, WHERE 25% OF FIRST-TIME VOTERS VOTED FOR THE NEO-NAZI PARTY IN PREVIOUS ELECTIONS, SLOVAKIA QUALIFIES AS A PERFECT COUNTRY TO MARK THE BEGINNING OF OUR INITIATIVE. ONCE THE FIRST ATTEMPT HAS BEEN MADE WITH SLOVAKIAN YOUTH, WE ARE PLANNING TO EXPAND OUR TARGET AUDIENCE TO OTHER EUROPEAN COUNTRIES.

CONSIDERING THAT TODAY'S YOUTH IS A DIGITALLY LITERATE GENERATION WHOSE EXPOSURE TO CONTENT AND INFORMATION IS ALMOST EXCLUSIVELY LIMITED TO SOCIAL MEDIA PLATFORMS, IPEAH INTENDS TO EXPLOIT THE POTENTIAL OF THE ONLINE SPHERE AND BRING ACCESSIBLE, PERSONALIZED, AND PARTICIPATORY TRAINING ACTIVITIES. THIS WILL ALLOW US NOT ONLY TO REACH A WIDER AUDIENCE BUT ALSO SIGNIFICANTLY CONTRIBUTE TO COST SAVING AS WELL.

THE PROJECT FINAL EVENT WAS THE "KNOWLEDGE, MEMORY, AND HUMAN RIGHTS" CONFERENCE, HELD IN PRESENCE IN THE CITY OF ROME ON THE 27TH OF JANUARY 2023 FROM 9.00 TO 13:00 CET, ALSO COMMEMORATING THE HOLOCAUST REMEMBRANCE DAY AND THE EVENTS OF 1943, 80 YEARS AFTER THE START OF THE DEPORTATION OF THE ROMAN JEWS.

THIS YEAR WE CLOSED THE PROJECT “YOUTH DEBATING THE FUTURE OF EUROPE” (U4EU) GIVING VOICE TO YOUNG CITIZENS ABOUT THE FUTURE OF EUROPE!

THE U4EU PROJECT AIMED TO ENCOURAGE THE DEMOCRATIC AND CIVIC PARTICIPATION OF YOUNG CITIZENS IN GREECE, BULGARIA, PORTUGAL, SPAIN, ITALY, GERMANY, HUNGARY, BELGIUM AND THE NETHERLANDS, AND TO HELP THEM EXPRESS THEIR CONCERNS AND VISIONS ABOUT THE EUROPEAN UNION.

THE PROJECT WAS CO-FUNDED BY THE EUROPE TO CITIZENS PROGRAMME OF THE EUROPEAN UNION AND IT CULMINATED WITH THE MAKING OF THE E-PUBLICATION “WHAT DOES EUROPE MEAN FOR THE EUROPEAN YOUTH?: VIEWS FROM THE FIELD” IN JULY 2022. THIS DOCUMENT PROVIDES A SUMMARY OF THE 7 U4EU COMMUNITY DIALOGUE EVENTS, THE INFO DAY AND THE YOUTH WORKSHOP THAT WERE ORGANISED DURING THE IMPLEMENTATION OF THE EUROPE FOR CITIZENS PROJECT “YOUTH DEBATING THE FUTURE OF EUROPE (U4EU)” IN NINE EUROPEAN COUNTRIES (GERMANY, ITALY, THE NETHERLANDS, BELGIUM, HUNGARY, PORTUGAL, SPAIN, GREECE, AND BULGARIA) FROM SEPTEMBER 2021 UNTIL JUNE 2022.

DURING THESE EVENTS, 396 YOUNG PEOPLE (IN TOTAL) FROM DIFFERENT EU COUNTRIES WERE PARTICIPATING WITH THE PURPOSE TO GENERATE A DEBATE ABOUT THE FUTURE OF EUROPE, TO PROVIDE ALTERNATIVES TO EXISTING PROBLEMATIC SITUATIONS AND TO GET INFORMED ABOUT THE PROJECT AND THE IMPORTANCE OF VOLUNTEERING AND YOUTH PARTICIPATION.

GLOBAL DIALOGUE ON YOUTH PARTICIPATION & PEACE

UNITED FOR INTERCULTURAL ACTION HAS PARTNERED WITH SEVENTEEN OTHER NON-GOVERNMENTAL YOUTH-LED INSTITUTIONS TO DELIVER ERASMUS+ WORLDWIDE: GLOBAL DIALOGUE ON YOUTH PARTICIPATION & PEACE, A PROJECT AIMED TO ESTABLISH STRONGER YOUTH COOPERATION BETWEEN YOUNG PEOPLE COMING FROM EUROPE, THE DIASPORA, ASIA, AND AFRICA.

OVER 50 PARTICIPANTS COLLABORATED IN DIFFERENT ONLINE CAPACITY-BUILDING WORKSHOPS, NAMELY: (1) "EXPLORING YOUTH PARTICIPATION IN LOCAL AND INTERNATIONAL GOVERNANCE", (2) "YOUTH MOVEMENTS & DECOLONISING CLIMATE JUSTICE" AND (3) "YOUTH ACCESS TO FUNDING", CONDUCTING EXTENSIVE DISCOURSE AND DISCUSSION TO PRODUCE MEANINGFUL POLICY RECOMMENDATIONS THAT TACKLE THE ISSUES AND REDEFINE THE ROLE OF YOUTH IN THE PARTICULAR AREAS AFOREMENTIONED. THE RECOMMENDATIONS WERE THEN LATER SHARED WITH THE PUBLIC AND WERE RECEIVED BY RELEVANT INTERNATIONAL INSTITUTIONS AND KEY DECISION-MAKERS. AND SO, NOT ONLY WERE THE PARTICIPANTS ABLE TO AMPLIFY THEIR VOICES IN THE NATIONAL AND INTERNATIONAL ARENA BUT THEIR INDIVIDUAL SKILLS AND UNDERSTANDING WERE ALSO DEVELOPED, WITH THEIR REACH AND NETWORK WIDENING THROUGH THIS GLOBAL DIALOGUE PROGRAM.

THE PROJECT WAS COORDINATED BY UNITED'S ADVOCACY ADVISOR, NERINGA TUMENAITE. THE PARTICIPANTS ALSO HAD A CHANCE TO MEET UNITED'S DIRECTOR BALINT JOSA, WHO PRESENTED BEST-CASE PRACTICES AND LESSONS LEARNED FROM MANAGING AN INTERNATIONAL NETWORK.

EXPLORING YOUTH PARTICIPATION IN LOCAL AND INTERNATIONAL GOVERNANCE

DESPITE THE FACT THAT THE IMPORTANCE OF THE ROLE OF YOUTH IS INDISPUTABLE WHEN IT COMES TO EXAMINING TRENDS AND MOVEMENTS OF CHANGE IN SOCIETY, YOUNG PEOPLE ARE STILL OFTEN OVERLOOKED, UNDERVALUED, AND EXCLUDED AT KEY MOMENTS, ESPECIALLY IN DECISION-MAKING. THIS IS SOMETHING TO BE QUESTIONED, ESPECIALLY AS YOUNG PEOPLE MAKE UP HALF OF THE WORLD'S POPULATION TODAY. NO MATTER WHAT THE INTERNATIONAL POLITICAL ACTORS DECIDE UPON, IT IS THE YOUTH WHO WILL BEAR THE CONSEQUENCES OF IT IN THE FUTURE.

IN THIS WORKSHOP, UNITED HELPED ORGANIZE A SPACE WHERE YOUNG PEOPLE ASSESSED THEIR CURRENT INVOLVEMENT IN LOCAL, NATIONAL, AND INTERNATIONAL SOCIETY. FACED WITH ISSUES AND COMPLICATIONS THAT SLOW, HINDER, AND ENDANGER THEM TOWARDS ACTIVE AND CONTINUOUS PARTICIPATION IN LOCAL AND INTERNATIONAL GOVERNANCE, PARTICIPANTS WERE ABLE TO COME UP WITH AT LEAST 31 COMMENDATIONS THAT WERE THEN CONSOLIDATED AND FINALIZED TOWARDS THE FINAL OUTCOME OF THE REPORT, WHICH YOU CAN ACCESS HERE.

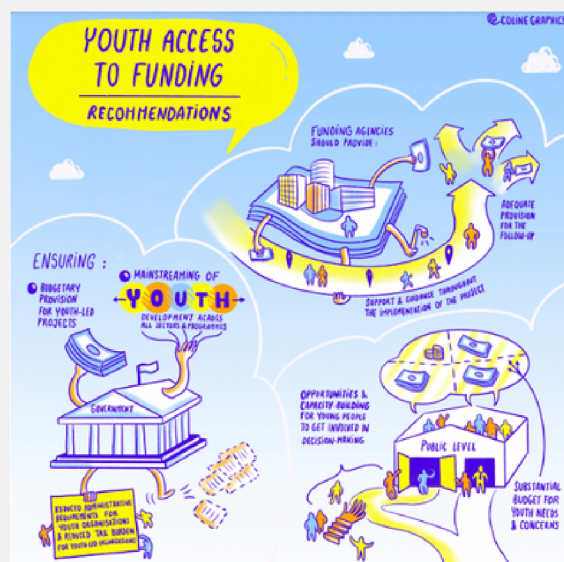
OVER 50 YOUNG PEOPLE GATHERED FOR THE WORKSHOP, ON WHICH MANY HIGHLIGHTED THE VARYING DEGREES OF CHALLENGES AND BARRIERS THAT RESTRICT THEM FROM GETTING INVOLVED IN AND ACROSS ALL GOVERNMENT SECTORS, AGENCIES, AND PROGRAMS. THE PARTICIPANTS ALSO HAD A CHANCE TO HEAR ABOUT BEST-CASE PRACTICES IN FUNDRAISING FROM UNITED'S DIRECTOR BALINT JOSÁ.

FOR THE MANTRA OF THE UN SDG GOAL: "LEAVE NO ONE BEHIND," TO ACTUALLY TAKE EFFECT, HERE ARE RECOMMENDATIONS ACCORDING TO PARTICIPANTS THAT THE GOVERNMENTS SHOULD CONSIDER.

YOUTH MOVEMENTS & DECOLONISING CLIMATE JUSTICE

AS CLIMATE CHANGE CONTINUES TO BE A CRITICAL CHALLENGE OF OUR GLOBALIZING SOCIETY, THERE IS ESPECIALLY A NEED FOR THE YOUTH TO RESHAPE THIS ALREADY EXISTING KNOWLEDGE OF THE DANGERS IN THE ENVIRONMENT AND REDIRECT THE ATTENTION BACK TO THE GLOBAL SOUTH TO SOLIDIFY THE GROUNDS ON WHICH THEY STAND. IT IS ONLY NECESSARY THAT WE LOOK BEYOND 'CONVENTIONAL SCIENCE' KNOWLEDGE AND INSTEAD DEMAND ACCOUNTABILITY FOR THE HISTORICAL INJUSTICES THAT HAVE CAUSED IT.

THE CONTRIBUTION OF YOUTH-LED MOVEMENTS SHOULD NOT BE OVERLOOKED; THEIR IMPACT AND EFFORTS ON DECOLONIZING CLIMATE JUSTICE SHOULD BE ACKNOWLEDGED. WITH THE INCLUSION OF THE YOUTH IN JOINT POLICY AND STRATEGIC EFFORTS, THE DECOLONIZATION OF CLIMATE JUSTICE COULD MOVE PAST THE NOTION OF VICTIMHOOD TOWARDS A PATH OF GREATER OPPORTUNITIES TO ACHIEVE TRUE CLIMATE JUSTICE. IN THIS WORKSHOP, PARTICIPANTS EMPHASIZED THE FIGHT AGAINST THE UNEQUAL DISTRIBUTION OF CLIMATE CHANGE AND ITS TREMENDOUS IMPACTS ON HUMANITY, ESPECIALLY ON THE MARGINALIZED. HERE'S HOW THE PARTICIPANTS DECIDED TO MOVE FORWARD.
